

**FOCUS ON THE FAMILY
“GET IN THE SHOW” CONTEST
OFFICIAL RULES
2017**

IF YOU DO NOT RESIDE IN THE 50 UNITED STATES OR THE DISTRICT OF COLUMBIA YOU ARE NOT ELIGIBLE TO PARTICIPATE IN THIS CONTEST.

Participation in the Focus on the Family “Get in the Show” contest (the "Contest") is contingent on your full and unconditional agreement to and acceptance of these Official Rules. The Contest is sponsored by Focus on the Family, 8605 Explorer Drive, Colorado Springs, CO 80920 ("Sponsor").

1. NO PURCHASE IS NECESSARY.

2. CONTEST. Video record yourself reading one (1) of two different scripts. Scripts will be provided by Sponsor at whitsend.org/getintheshow (“Contest Website”) on or about May 15, 2017. Entries may be recorded either at a participating bookstore or at a location of entrant’s choosing. Record your entry with your phone, camera, or another audio/visual recording device. Then submit your entry at the Contest Website between June 1, 2017, and June 16, 2017, at 11:59 pm Mountain Time (MT) (“Contest Period”). Entries must be submitted by the parent or legal guardian of entrant.

3. ENTRY. Your entry must be your original presentation using a script provided by Sponsor. All entries become the sole and exclusive property of Sponsor and will not be returned. Receipt of entries will not be acknowledged. Entries must be received by Sponsor during the Contest Period. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, or misdirected entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor. By entering, you agree to the terms and conditions of these Official Rules and to the display of your entry, in whole or in part, in any manner and media.

4. ELIGIBILITY. Participation is open only to legal residents of the fifty United States or the District of Columbia who are between the ages of 6 and 15, inclusive, at the time of entry. Proof of age and legal residency may be required. Void outside of the 50 United States and the District of Columbia, and where prohibited, taxed or restricted by law. Employees, officers & directors of Focus on the Family, its Contest advertising and promotion agencies, and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees/ officers/ directors are not eligible to enter. Entrant must be an individual person; group entries are not permitted, although entrant may include others within the video entries.

4.1 A limit of one entry per person is allowed. A video submission will constitute an entry by only one person, even if more than one person appears in the video; additional persons in the video must resubmit the video (or another video) to be considered a Contest entrant. Multiple entries determined to be submitted from the same individual will invalidate all entries from that individual.

5. WINNER SELECTIONS. By June 25, 2017, Focus will select the top 50 entries received during the Contest Period, based on the following criteria: ability to convey emotions and reaction,

proficiency in reading, and unique vocal characteristics. The top 50 entries will be posted at the Contest Website by June 26, 2017. The subsequent winning entries, and ultimately the grand prize winner, will be selected by online fan voting in phases.

Phase 1, Top 50 posted for fan voting. Voting period: June 26-July 8, 2017

Phase 2, Top 25 posted for fan voting. Voting period: July 10-14, 2017

Phase 3, Top 10 posted for fan voting. Voting period: July 17-23, 2017. Top 3 entrants selected.

Phase 4, Grand Prize Winner selected during the live audition on August 12, 2017

During each Phase, fans may vote for one entry only according to the voting instructions at the Contest Website. The finalists whose entries receive the most number of votes during the Phase voting period will be selected as the finalists for the next Phase; however, Sponsor reserves the right to determine the finalists at its discretion.

The grand prize winner will be selected by fan vote on August 12, 2017, from among the three finalists participating in the live audition in Colorado Springs on August 12. The live audition will be webcast on August 12, and votes will be received at the Contest Website. One vote per person. Votes must be received on August 12 within the voting period that will be announced during the live audition. The finalist who receives the most votes will be the grand prize winner; however, Sponsor reserves the right to determine the grand prize winner at its discretion.

6. PRIZES & APPROXIMATE RETAIL VALUES.

The top 100 finalists will each receive Adventures in Odyssey album 62, valued at approximately \$15.00. The top 10 finalists will also receive a one-year membership to the Adventures in Odyssey Club, valued at approximately \$120.00. The top 3 finalists will receive a trip to Colorado Springs for the finalist and guest (parent or legal guardian) to attend the live audition on August 12, 2017; trip includes roundtrip domestic airfare for two (or gasoline reimbursement, if driving), hotel, ground transportation, and meals in Colorado Springs, all valued at approximately \$2,000.00. The grand prize winner will receive a trip on the Focus on the Family 40th Anniversary Cruise to the Bahamas, November 12-17, 2017, for the winner and three guests (at least one guest must be the winner's parent or legal guardian). Approximate grand prize value is \$7,800.00. All guests under 18 must be accompanied on the cruise by a parent or legal guardian of the guest. The grand prize includes domestic airfare for four persons to and from the port of departure (or reimbursement for gasoline, if driving); cruise accommodations for four aboard the *Disney Dream*, November 13-17, 2017.

Grand prize winner and guests will be responsible to obtain all required travel documents.

Prize may not be assigned, transferred, changed, or redeemed for cash, except at Sponsor's sole discretion. No cash alternative will be offered. No substitutions of prize, except that Sponsor may substitute any portion of a prize with something of equal or greater value, in Sponsor's sole discretion. Any portion of a prize not accepted by a winner is forfeited. All federal, state and local taxes are the sole responsibility of the winner.

7. NOTIFICATION. The top three (3) finalists will be notified on or about July 26, 2017, by telephone or by email. The parent or legal guardian of the three (3) top finalists may be required to sign and return an Affidavit of Eligibility and/or Liability/Publicity Release, and a W-9 form for tax reporting purposes, within ten (10) days of receipt. Further, a Liability/Publicity Release may be required from each additional individual appearing in a Contest entry. In addition, a Liability/Publicity

Release may be required from (or on behalf of, if a minor) each additional individual participating on the cruise to the Bahamas as a guest of the grand prize winner. If a potential winner does not respond within five (5) calendar days of first notification attempt by Sponsor, if any prize or prize notification is returned as undeliverable, if a potential winner rejects his/her prize, if potential winner does not sign and return the requested forms within ten (10) days of receipt, if all other individuals appearing in an entry or participating as a guest on the cruise to the Bahamas do not sign and return (or if a minor, have his or her parent sign and return) a requested Liability/Publicity Release form within ten (10) days of receipt, if a top-three finalist is unable to attend the live audition in Colorado Springs on August 12, 2017, or if a top-three finalist is unable to attend the Focus on the Family 40th Anniversary Cruise November 13-17, 2017, or in the event of noncompliance with these Official Rules, the prize will be forfeited and Sponsor reserves the right to select an alternate winner from all remaining eligible entries. Upon prize forfeiture, no compensation will be given.

8. CONDITIONS. Participation in this Contest and acceptance of a prize constitutes entrant's permission for Sponsor to (a) use his/her name, address (city and state), likeness, photograph, picture, voice, biographical information, entry and/or any statements made by entrant regarding the Contest or Sponsor and (b) copy, edit, use in any medium and manner, in whole or in part, the entry submitted for any purpose without notice or additional compensation, except where prohibited by law. By participating, entrant agrees to release and hold harmless Sponsor and Sponsor's advertising and promotion agencies and their respective parent companies, subsidiaries, affiliates, licensees, partners, representatives, agents, successors, assigns, and the employees, officers and directors of each of them, from any and all liability, for loss, harm, damage, injury, cost or expense whatsoever including without limitation, property damage, personal injury and/or death which may occur in connection with entrant's participation in this Contest, or possession, acceptance and/or use, misuse or non-use of prize or participation in any Contest-related activity and for any claims based on publicity rights, defamation or invasion of privacy and merchandise delivery. Sponsor is not responsible if any prize cannot be awarded due to delays or interruptions due to acts of God, acts of war, terrorism, natural disasters, weather, acts of terrorism, or any other events outside of Sponsor's control. Entrants who do not comply with these Official Rules or attempt to interfere with this Contest in any way will be disqualified, all of entries from that entrant will be voided.

9. ADDITIONAL TERMS. No automatic, programmed; robotic or similar means of entry are permitted. Sponsor, its affiliates, partners and promotion and advertising agencies are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, web site, Internet, or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate capture of entry information (regardless of cause) or failed, incomplete, garbled, jumbled or delayed computer transmissions which may limit one's ability to enter the Contest, including any injury or damage to entrant's or any other person's computer relating to or resulting from participating in this Contest or downloading any materials in this Contest. Sponsor reserves the right, in Sponsor's sole discretion, to cancel, terminate, modify, extend or suspend this Contest should (in Sponsor's sole discretion) virus, bug, non-authorized human intervention, fraud or other cause beyond its control corrupt or affect the administration, security, fairness or proper conduct of this Contest or for any other reason Sponsor deems it necessary. In such case, Sponsor may, at its discretion, select the winners from all eligible entries received unaffected by the problem. Sponsor reserves the right, at its sole discretion, to disqualify any individual it finds, in its sole discretion, to be tampering with the entry process or the operation of this Contest or web site. Sponsor may prohibit an entrant from participating in the Contest or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of this Contest by cheating, hacking, deception, or other unfair playing practices

(including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other entrants or Sponsor representatives.

EACH ENTRANT WAIVES ANY AND ALL OBJECTIONS TO AND HEREBY SUBMITS TO THE JURISDICTION AND VENUE OF THESE COURTS.

10. USE OF DATA. Sponsor will be collecting personal data about entrants online, in accordance with its privacy policy. Please review the Sponsor's privacy policy at www.focusonthefamily.com/about_us/privacy_policy.aspx. By participating in this Contest, entrant hereby agrees to Sponsor's collection and usage of entrant's personal information and acknowledges that entrant has read and accepted Sponsor's privacy policy. By entering the Contest, you agree that Sponsor may send you advertising, promotional, and other informational material. You may opt out of receiving these materials at any time by notification to Sponsor.

11. OWNERSHIP OF ENTRY. By submitting an entry, you acknowledge and agree that: (a) Sponsor will own your entry, and (b) as between you and Sponsor, Sponsor will own all publishing rights in and to the entry. Each entrant hereby irrevocably grants, transfers, sells, assigns and conveys to the Sponsor, its successors and assigns, all present and future right, title and interest of every kind and nature whatsoever, including, without limitation, all copyrights, and all rights incidental, subsidiary, ancillary or allied thereto (including, without limitation, all derivative rights) in and to the entry and the written response submission(s) for exploitation throughout the universe, in perpetuity, by means of any and all media and devices whether now known or hereafter devised. Sponsor shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter, the entry for any purpose which Sponsor deems necessary or desirable, and each entrant irrevocably waives any and all so-called moral rights they may have in the entry submitted by him or her.
